AiR Goyki 3 – residency programme regulations

I. Residency programme description

- 1) Goyki 3 Art Inkubator with its registered office in Sopot at Goyki 3 street, entered in the register of the local government cultural institutions on 29 May 2019 under No. 5 and appointed by the resolution of the Sopot City Council No. V / 77/2019 on 28 March 2019, is a new local government cultural institution in Sopot, goal is to conduct activities aimed at creating and disseminating culture, promoting cultural education, and supporting creative communities (hereinafter referred to as 'Art Inkubator'). Art Inkubator will be involved in building a network of domestic and foreign stakeholders, and organising art residencies and creative work programmes. Art Inkubator will also be involved in art and culture research as well as organising cultural and artistic events and promoting the cultural and historical heritage of Sopot. - 2) The residencies under the Art Residencies Programme are dedicated to a wide group of artists – creators of visual art, writers, performance artists and individuals involved in the popularisation of science – and they consist in providing the residents with studios designated by Art Inkubator in which they can undertake artistic activities.
- 3) In AiR Goyki 3, we are interested in creative process and dialogue with artists. We are driven by critical reflection on the modern world and society. We do not specify what end results should be; we do not impose topics. We support well-thought-out activities and research-focused projects referring to the place of their implementation, i.e. the city of Sopot and the space of Art Inkubator, as well as those focused on building relationships between people and their surroundings. By inviting residents from various fields, we hope to promote networking and cooperation which will result in multidisciplinary projects.

II. Open call applicants

1.Must be over 18.

- a) For AiR Goyki 3 in 2022 the main focus is on the field of visual arts or literature.
- 2. Excluded from the applications are:
- a) jury members
- b) Goyki 3 Art Inkubator staff and partners

III. Residency conditions

- 1. There is no residency fee.
- The residency duration is 2 months. Throughout the time, the residents are required to stay and undertake artistic activities in Sopot. In reasonable cases, the Director of Goyki 3 Art Inkbator may change the duration of the stay.
- 2) Those granted the residency will be obliged to conclude a relevant contract and organize at least one open meeting dedicated to their artistic creations or using works resulting from their creative efforts. The dates will be determined with the AiR staff.
- 3) Throughout the residency period, the residents will have to comply with the studio access conditions set forth in the contract.
- 4) AiR Goyki 3 offers:
- a) access to an atelier in the building used by Art Inkubator;
- b) curatorial support during residencies;
- c) opportunities for networking with the local art scene, arranging meetings and visits to institutions relevant to residents' profiles;

- d) accommodation for two residents in Sopot during the April-June residency period; the location will be determined by Art Inkubator;
- e) covering project implementation costs up to the amount of PLN 8,000 gross per resident in the case of the September November residencies.
- 5) Art Inkubator does not cover travel expenses.
- 6) Art Inkubator does not cover insurance expenses for the residency periods.

IV. Application procedure and necessary documents

- 1) Residency proposals can be submitted in English and Polish.
- 2) Necessary documents:
- a) a brief outline of the project to be carried out in the course of the residency (maximum 500 words/one A4 sheet);
- b) a portfolio, an artist statement with up to 6 realized projects including a technical description (maximum 3MB file size, PDF format obligatory);
- c) a resume with emphasis on the most recent projects and important awards;
- d) the contact sheet including artist's full name, email address, phone number, date of birth, country of origin and country of residence, preferred residency dates, also the field in which the project will be implemented, the list of attachments, information from where got to know about the AiR Goyki 3 program, and any additional information
- 3) Obligatory PDF file name format: candidatename_nameofthedocument_AiR Goyki 3
- 4) The applications have to be submitted directly via email at: air@goyki3.pl
- 5) The deadline for the submission of the documents is 05.11.2021, by 12.00 CET. Any applications submitted after that time will not be evaluated.

V. Jury

1) The jury will be composed of Art Inkubator representatives and professionals in the fields indicated in 2.1a).

The jury members of visual arts are: Romuald Demidenko, Rafał Milach, Kasia Sobczak The jury members of literature are: Marta Czarnecka, Maciej Jakubowiak, Małgorzata Semil

2) The jury's decisions may not be appealed against.

VI. Copyrights

- 1) Art Inkubator has the right to use all the materials submitted throughout the application process for the purposes of the jury's proceedings awarding the art residencies and selecting the people who will obtain such residencies. The residents shall ensure that the use of the above materials for the purposes specified in the preceding sentence will not infringe intellectual property rights or copyrights of third parties. The residents shall be required to cover any damages or to satisfy any legitimate claims of third parties, or of Art Inkubator, which may arise as a result of such violation.
- 2) Art Inkubator reserves the right to record photos and videos presenting the public aspects of the residencies e.g. studio open days, presentations, workshops, etc. and to use the collected data in the center's communications without prejudice to the rights of intellectual

or artistic property of their authors. The residents will be required to cover any damages or to satisfy any legitimate claims of third parties, or of Art Inkubator, which may arise as a result of any violation of the aforementioned rights.
